kNOw Opioids: An Addiction & Spirituality Conference — May 17, 2025 Faith Presbyterian Church

86% Said the information received was valuable.

Binge drinkers typically being college students do so to "fit in" and don't even realize it's a problem because everyone else is doing it. It's important to continue to bring awareness to this.
- Alcohol consumed under the age of 21 years of age is most likely due to peer pressure which I think is a
 main contributing factor to most under-age substance abuse. I also think that the reason most alcohol
 under the age of 21 is consumed largely as binge drinking because most youths think that this is how
 adults drink, just to get drunk. This is why statistics like this, and other educational information
 introduced consistently throughout education about alcohol and its consumption is important for

- I recently learned the importance of naloxone, thank you!
- This post is great, because we often don't consider asking prior to getting procedures done, we just want it to be done. I think this should be considered in medical practice as a patient right to ask about concerns. I wish I knew this sooner. I recently had my wisdom teeth taken out and they gave me opioids but I'm fine.
- Share awareness with your younger siblings if you have any. Young teens tend to be a major target group for this type of drug.
- I personally carry naloxone and fentanyl test strips now!
- Not many people realize the addiction can begin in the doctor's office, and not on purpose. These are
 perfect questions that many people should ask when being prescribed drugs with high addiction risks. Such
 questions are super helpful for everyone and a great way to raise awareness about potential risks of
 drugs.
- This is very educational to know since some people may not always understand properly what type of medication they are receiving and the possible side effects it can cause them. There is a vast need to educate those on opioids and its potential harm to users.
- We're learning about this in the class I'm currently taking and knowing the signs to look for to spot an overdose and the proper way to administer Naloxone is incredibly important!
